**AGREEMENT TO TERMS AND CONDITIONS OF SALE AND CREDIT POLICY**

The undersigned understand and agree that the following terms and provisions shall govern the open account with Standard Lite and Air Corporation (hereinafter "Company") and make the representations contained herein in order to induce the Company to extend credit to the Applicant: 1) I/We certify that the above information is correct and complete. 2) I/We understand that Company shall rely on the above information for the extension of credit and, from time to time, to obtain Credit Reports, credit and funding information on Applicant or any individuals/entities listed above and, by signing this Application, hereby authorize the Company to request and receive such information in connection with the extension of credit. 3) The Applicant shall notify the Company in writing promptly of any change in the name, address, type of ownership or structure under which credit is established. 4) The Applicant shall pay the Company in full for any invoice on or before the net due date as shown on each invoice. If not paid on or before said date, payment shall be deemed delinquent. 5) The Applicant shall pay the Company a service charge of one and one-half percent (1 ½%) per month, or eighteen percent (18%) per annum, or the highest legal rate, which ever is less, on any amount which becomes past due and delinquent. 6) Applicant further expressly agrees that it shall be liable for and shall pay all attorneys' fees, collection costs and court fees, and any other expenses, whether or not incurred in connection with litigation, associated with the enforcement of any of the terms of this Application or in connection with any delinquent account. 7) Applicant agrees to examine immediately upon receipt, each of the Company's invoices or statements of account and to advise Company of any disputed transactions within 10 days of receipt, together with a written statement specifying the reasons for such dispute. Failure to notify the Company of any dispute with respect to defective goods or billing shall constitute a waiver of all such disputes. 8) Company reserves its right, at its sole discretion and without notice, to cancel all available credit and refuse to make future advances. 9) I/We certify that this application is for the extension of credit for business purposes only and is not intended for the extension of credit for personal, family or household purposes. 10) This agreement shall be construed and enforced according to the laws of the Commonwealth of Pennsylvania and the parties submit to venue in Allegheny County, Pennsylvania if suit is brought to collect any delinquent balance owed. 11) I/we certify that as the person(s) executing this agreement, I/we have the authority to bind the Applicant and are authorized by the Applicant to enter into the credit application and to agree to the terms and conditions contained herein.
